### Advice for firefighters

DO NOT fight fire when fire reaches explosives.

Protective equipment and precautions for firefight. Wear a self-contained breathing apparatus and chemical protective clothing ers

### Additional information

Do not allow run-off from fire-fighting to enter drains or water courses.

Do not inhale explosion and combustion gases.

Use caution when applying carbon dioxide in confined spaces. Carbon dioxide can displace oxygen. Use water spray/stream to protect personnel and to cool endangered containers. In case of fire: Evacuate area.

### SECTION 6: ACCIDENTAL RELEASE

Personal Precautions:	In case of major fire and large quantities: Remove persons to safety.
Environmental Precautions:	Discharge into the environment must be avoided.
Method of Containment:	Small Spill: Dilute with water and mop up, or absorb with an inert dry material and place in an appropriate waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.
	Large Spill: Stop leak if without risk. Absorb with an inert material and put the spilled material in an appropriate waste disposal. Do not touch spilled material.
Method for Clean-Up:	Ventilate area of spill or leak. Sweep or scrap up and containerize in approved chemical waste container. Wash spill area with water.
