Terms are COD until approved by the Credit Department. Once approved, accounts are Net 30 days from the date of invoice.

All accounts with a past due balance of 31 days or more will be charged a late fee of 2% per month.

All accounts, which have balances past due by 45 days or more, shall have their credit privileges suspended or revoked and orders will not be processed until the past due balance is paid in full. We reserve the right to remove any discounts if accounts go past due.
